The candidate who wishes to apply / participate in the spot round/s needs to register on the following link and pay the processing fees of Rs.2000/- (nonrefundable-nontransferable), if NOT paid earlier. No need to pay the registration fees, if already paid for any of the SPOT/ACAP round earlier conducted by VIT Pune.

However, it is MANDATORY to register for the ADDITIONAL SPOT Round/s to be conducted on 23<sup>rd</sup> October 2024.

- 2. The Seats Vacant for additional SPOT Round, if any, shall be notified on the institute's website and notice boards on 22/10/2024 by 7.00 PM
- 3. If seats remain vacant due to betterment or cancellation, the further additional multiple spot rounds will be conducted on 23rd October 2024 after this additional SPOT Round for all Maharashtra State and All India candidates, on 23rd October 2024. Admission round stages will be conducted as per the information brochure of GOVERNMENT OF MAHARASHTRA State, Common Entrance Test Cell, for the Academic Year 2024-25

### NOTE for ACAP (Non-CAP seats) Registered Candidate:

**1.** Candidates who have registered with CET CELL and Verified the documents as per the CET Cell guidelines shall report to VIT Pune, Auditorium **at 8:00 am, 23rd October 2024**, for obtaining merit number as per his/her score in MHT-CET/JEE(Mains) 2024.

2. Candidates are advised to check the schedule given in Table 1 of this notification and plan to report to the venue at least 2 hours before his/her anticipated merit number in accordance with the Final Merit List Published by CET –CELL on ttps://fe2024.mahacet.org.

### Admission rules and Instructions:

- 1. The schedule given above is provisional & may change due to unavoidable circumstances. The revised schedule will be notified separately.
- 2. Vacancy positions will be displayed on the institute website and on the noticeboard before the round commences. It is MANDATORY to apply to the round. It is also mandatory to download the application form from the portal/link provided immediately after registration and payment of fees.

- 3. These admissions will be made strictly in the order of inter-se merit amongst the candidates who have registered to the given link in given time limit and then report in person for admission to VIT, Pune Auditorium against the seats available in various courses / programs at that moment.
- 4. During this round, only 1 allotment will be made to a student in one Stage of admission. Students can appear for betterment in subsequent stages ONLY. Change of branch/seat will not be done during the ongoing stage. Students, once entered in the Auditorium, will have to pass through the entire admission process and shall not be allowed to re-enter in the auditorium during the ongoing stage/round.
- 5. Reporting the candidates to Main Auditorium, VIT Pune is strictly as per the schedule mentioned in Table No-1. The seat allotment will be carried out based on the vacancy status at that point. Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats displayed on the auditorium screen. Candidates are advised to be present in the auditorium and wait for their turn as per inter-se merit. If a candidate is found unavailable when called, the next candidate on the merit rank would be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment. Please note that the vacancies will be updated dynamically, it means when a student cancels the existing admission or goes for a betterment, the corresponding seat will be immediately updated/ added in the seat matrix and will be offered to the next merit number onwards.
- 6. Suppose a candidate of higher merit reports late during the process of counseling. In that case, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that moment.
- 7. **Only Candidate in person** will be allowed to participate in the admission process. Parents will have to wait outside on the lawn or ground
- 8. The admission process will be conducted as per rules and regulations published in the information brochure by State CET Cell for AY 2024-25 (for details refer to <u>www.mahacet.org</u>).
- 9. Seat type namely TFWS & EWS, if remains vacant after the end of CAP rounds shall not be filled during the counselling round as per State CET Cell rules.
- 10. The candidate shall produce the documentary evidence strictly in support of their claims made in the applications. If a candidate fails to substantiate the claims made at the time of submitting necessary original documents within the scheduled period mentioned above, the candidate forfeits the claim of allotted seat.
- 11. The candidate shall confirm the admission by paying the requisite amount of fees and by submitting required documents in the original at the time of reporting to the Institute.
- 12. All Candidates irrespective of their caste and category of admission, admitted through this round will have to pay full fees (applicable for open category). Fees for Vishwakarma Institute of Technology is Rs. 1,92,945/-
- 13. The admissions will be done as per the guidelines of Govt. of Maharashtra State Common Entrance Test Cell.
- 14. The decision of the Chairman Admission committee shall be final and binding.
