If a candidate fails to substantiate the claims made at the time of submitting necessary original documents within the scheduled period mentioned above, the candidate forfeits the claim of allotted seat.
6. Document verification for admission is mandatory to be done “**in person**” by the Candidate at the Institute.
7. Candidates shall confirm the admission by paying the requisite amount of fees and by submitting required documents in original at the time of reporting to the Institute.
8. The admissions will be done as per the guidelines of Govt. of Maharashtra – State Common Entrance Test Cell.
