3. **Imp Note: All the students whose name appears in the revised final merit list for the additional IL round published on the institute website on 14th October 2024, need not pay application processing fees of Rs.2000/- however they MUST apply for this round explicitly, if they wish to participate in this round.**
4. **The admission process will begin with the allotment to the MS seats, followed by the AI seats.**

If a candidate fails to substantiate the claims made at the time of submitting necessary original documents within the scheduled period mentioned above, the candidate forfeits the claim of allotted seat.
7. Document verification for admission is mandatory to be done “**in person**” by the Candidate at the Institute at the time of round.
8. All the candidates whose names appear in the final merit list of this round shall report to the institute on **22nd October 8:00 am** sharp with all the required documents and DD/Cheque for the fees payment
9. Candidates shall confirm the admission by paying the requisite amount of fees and by submitting the required documents in original at the time of reporting to the Institute.
10. The admissions will be done as per the guidelines of Govt. of Maharashtra – State Common Entrance Test Cell.
